4	ASA Athletes Registration Form (See attached)	<ul style="list-style-type: none"> All athletes MUST complete the ASA Registration form before releasing the 2021 licences. Clubs MUST lodge the ASA Registration forms with KZNA.
5	Movement of athletes from one Club to another. Refer to Domicilium Rule 5.15 and specifically Rule 5.15.6	<ul style="list-style-type: none"> The releasing club MUST issue a clearance letter which the receiving club will forward to KZNA.
6	Validity of 2020 licences	<ul style="list-style-type: none"> 2020 licences are valid until 28/02/2021. As from 01/03/2021, only 2021 licences will be valid.
7	Sanctioning of all events by ASA and KZNA..	<ul style="list-style-type: none"> All athletes are allowed to participate only in events sanctioned

8	2021 Road Race Fixtures	<ul style="list-style-type: none"> • Fixtures are finalized. • Note that no changes to the final fixtures will be allowed. The Covid-19 Regulations have EQUALLY IMPACTED NEGATIVELY on all clubs. • Race organizing clubs to immediately apply for Risk Categorization. • Apply to the local traffic authority for permission to use the Roads. • Secure the services of a safety officer. • Book the venue. • Send race flyers to KZNA Office for approval . • Secure Public Liability Insurance.
